"When my husband was

diagnosed with metastatic cancer in February, he asked physicians weather they would provide him the means to end his life quickly if he choose. They either evaded the question or said they were unable to comply” (Marcia). This evidence shows that with the laws that are in place they take this mans rights to decide to live or die and that should be his choice as a living person. “ In june he died at home in Massachusetts, with hospital care, but not in the way he wanted. I see no reason we should have been denied that final measure of control”(Marcia). This quote shows that wife of the patient shows that even that now he is done suffering, her and their family are upset that he was not granted his final decision. With these peoples real life experiences it shows that there are many pro-viewpoints that legalizing assisted suicide would be supported by many people.

3.The con viewpoint of the topic of legalizing assisted suicide is that it is morally wrong and violates the basics tenets of medicine. The hippocratic oath is a oath most doctors must take to become a certified doctor. The oath itself tells that all doctors cannot assisted any of their patients in ending their life. The oath is enforced very heavily and has sent doctors to jail for murder. “... but the exercising of healing people and killing people are opposed to one another” (Paul A13).
